



## DON'T BE BULLIED BY OBAMA AND BRITISH LIES AND EMPTY THREATS

October 13, 2016—President Barack Obama, on behalf of the British System, is engaging in a Big Lie campaign, threatening war against Russia and China. With the French Hollande government in tow, Obama is making gestures about military intervention into Syria, about bringing Russia before the International Criminal Court in The Hague for war crimes in Aleppo, and similar bluster.

But the reality is that this British-directed campaign of lies and threats is driven by a total fear and panic on their part, and they have no capacity to actually deliver on their threats or to prove their lies if they are called out.

The British are going mad over the prospect of a total loss of power, as their trans-Atlantic financial system is set to blow up. It has now been openly admitted that the European Central Bank covered up the bankruptcy of Deutsche Bank when it conducted the so-called stress tests late last year. Non-existent assets, derived from sales that never happened, were booked as capital reserves by Deutsche Bank to hide the fact that they are doomed, unless they are put through a total restructuring, with their 46 trillion euros in derivatives cancelled, and a return to traditional German retail banking. HSBC, the flagship of the City of London's offshore dope empire, put out an emergency warning on Wednesday of an imminent blow-out of the trans-Atlantic stock market bubble.

In Syria, the bottom line is that the US, Britain, France and the Gulf States have spent billions of dollars, building a hardcore Islamic State and Al Qaeda terrorist apparatus to overthrow the Assad government, and Vladimir Putin stepped in and ruined their scheme. Now, the Syrian Army, with Russian support, is on the verge of crushing those terrorist networks in Aleppo. And so the French, the British and the Obama Administration are all accusing Putin and Russia of war crimes in Syria, while they engage in outright crimes against humanity in Yemen. The Obama Administration is now threatening a direct military intervention there to bolster the pathetic Saudis, which would only further the list of crimes against humanity carried out by Obama.

To cover up their own panic and actual terror over

the looming crash of their entire system, the British are carrying out a vicious campaign to frighten and demoralize the American people, principally by turning the US presidential elections into a pornographic nightmare, through the controlled media.

There are real issues, as well, that are causing panic among the American people. First and foremost, the collapse of the Obamacare program, anticipated from the outset by Lyndon LaRouche, has terrified a vast majority of Americans who find themselves facing an impossible situation of 50 percent boosts in annual healthcare premiums and dramatic cuts in services. Even former President Bill Clinton recently told a rally in Michigan that Obamacare is a disaster: "You've got this crazy system where all of a sudden 25 million more people have health care, and then the people who are out there busting it, sometimes 60 hours a week, wind up with their premiums doubled and their coverage cut in half and it's the craziest thing in the world."

The American people have every right to be angry, but not to be intimidated or bullied by a pack of liars, led by President Obama. The American people need to hear the truth: The entire British-Saudi system, which owns President Barack Obama, is finished, starting with their bankrupt financial empire. There are readily available solutions, starting with the reinstatement of Glass Steagall and then the immediate launching of a Hamiltonian recovery, utilizing the methods spelled out in Treasury Secretary Alexander Hamilton's Reports to the US Congress on manufacturing, credit and the national bank. These principles were revived in Lyndon LaRouche's Four Cardinal Laws. They are ready to be implemented right now.

To restore the fighting spirit that led to the recent dramatic victory in the JASTA fight, which delivered a devastating blow to the heart of the Anglo-Saudi empire of terrorism, the American people need to be told laugh at the Obama-British lies, and to get on with the serious business of building a post-British empire world of infinite opportunities and progress. Russia, China, India and other leading nations are already moving in this direction, and it's time for the United States to get in on the future.
