With the Federal Reserve uttering billions of dollars daily to cover any one of several secret banking crises, and the central bankers led by Mark Carney of the Bank of England calling for “regime change” to override sovereign governments—including emphatically overthrowing the duly elected President of the United States—it is incumbent upon the American people to arm themselves with knowledge of the solution to this crisis.

According to Lyndon LaRouche, the first question to ask yourself is, “What do you think the United

States and the world should look like 50 years from now?” From that standpoint, LaRouche developed his Four Laws for economic recovery, which are not “a choice but a necessity.” The Four Laws elucidate the parameters of necessary action, and elaborate a method of thinking based on the true nature of humankind and the universe itself.

Four powers in the world have the economic potential to overcome the collapse of the dead British imperial financial system: the United States, China, Russia, and India. The desperate oligarchs see the same thing LaRouche did in these four nations. It is not an accident that the British House of Lords have focused their destructive strategies on these four powers exclusively, and they have set out to divide these nations against one another. And, the deadly British system will take the world down in its collapse unless these four powers join in a new Bretton Woods credit system for crash development of the world’s economies.

It is not enough to say that you ‘support the President’ and yet sit idly by and ‘wait to see what will happen in the November 2020 elections.’ It is time that you realized that *you* must take action now in fighting to bring about the urgently needed solutions to save our Republic. end of the party system.” The fight at hand is bigger than merely which political party you side with, but rather who is providing the leadership needed and solutions required to secure the future.
